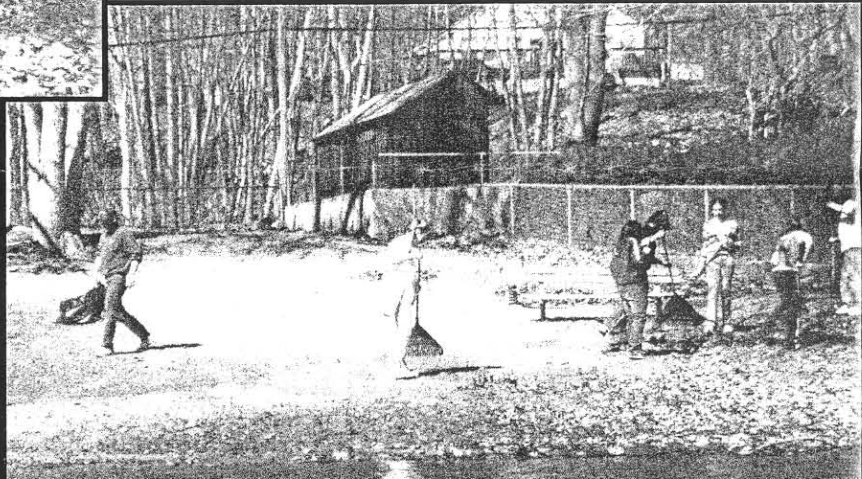

STATE BOATING REGULATIONS

- Anyone 12 and over using an electric motor needs a boating license from the State of Connecticut.
- Life jackets **MUST BE WORN** in all boats including canoes, row boats and paddle boats until May 31st. Thereafter, they must be in the boat/vessel with an appropriate life jacket size for each person plus one floatable device.
- THE STATE OF CONNECTICUT DEP will be conducting sporadic boat checks and inspections this summer.
- Anyone over the age of 16 must have a fishing license. Age 65 and over are free. Check with your town clerk.

Water Testing

The 1st water test will be taken the last week of June; thereafter it will be taken bi-weekly.



Roads

The dirt roads will be graded by the completion of the second week of May. We are going to try and pave 1/2 of Shorefront Drive this year.

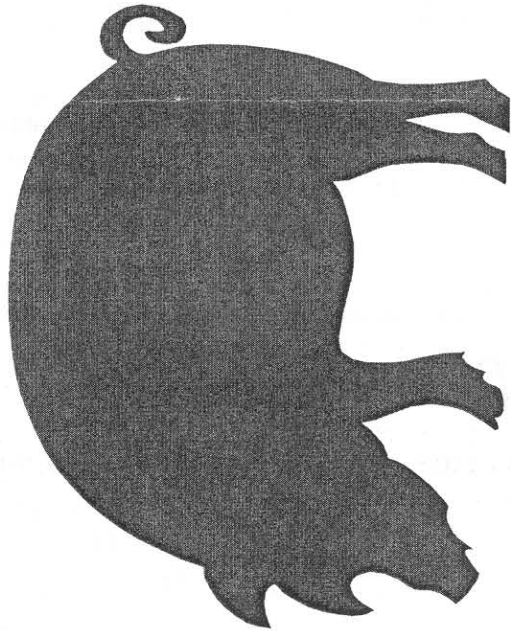

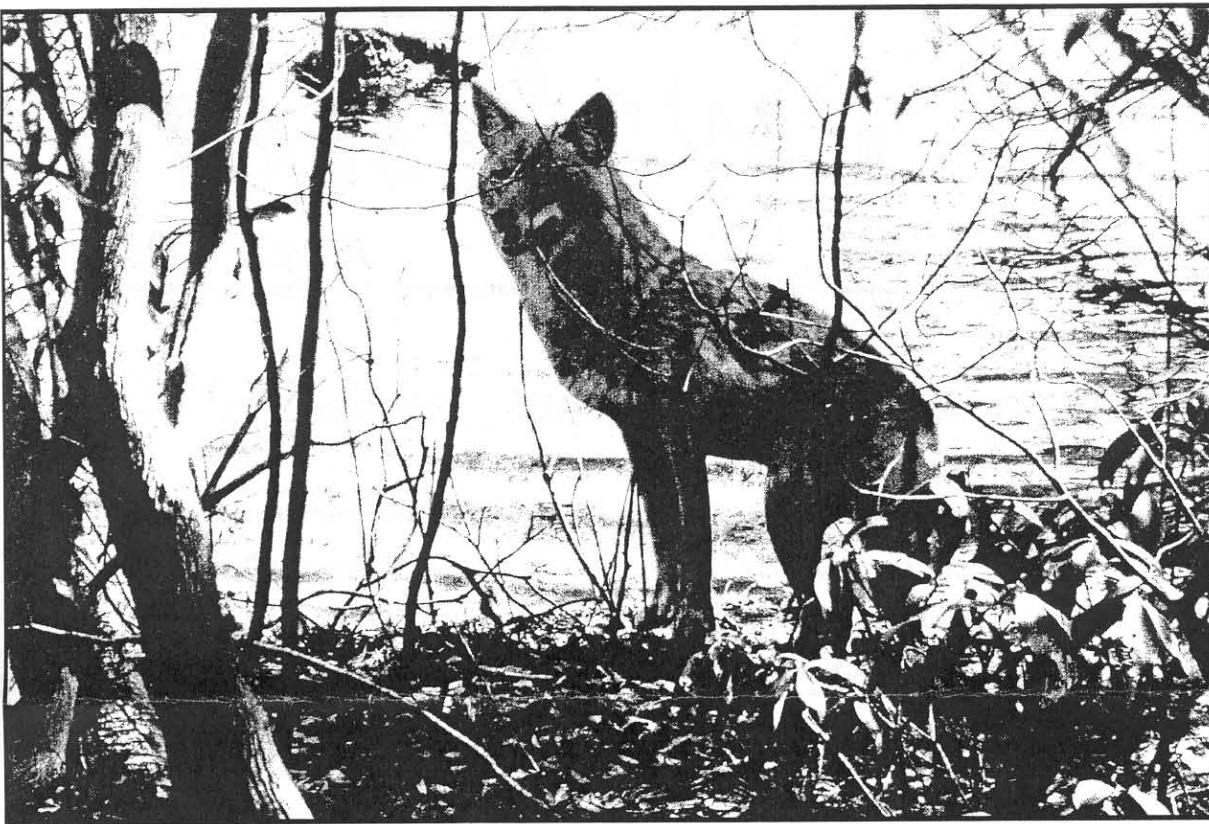

Wyle E. Coyote at Lake Chaffee?

No! You don't need my glasses! Canada geese have been troublesome to Lake Chaffee for many years. What to do about them? Diana Murray mentioned at our board meeting that some places have had good luck in ridding their area of Canada geese by putting out fake coyotes. Two days later *The Hartford Courant* ran an article on the subject.

Coyotes are the natural predator of the Canada geese. We found the company that produces the fake, weatherproof, corrugated plastic coyotes. I felt that the Association would benefit from these coyotes if it worked. I ordered six with Kay Warren and Pauline Backhaus ordering for their homes and four for the islands (two on each). By posing the coyotes around and moving them about every three days so the geese feel that there are a lot of them here, it has been worth it. We have not seen any geese in the areas of the coyotes. **IF YOU GO TO THE ISLANDS PLEASE DO NOT REMOVE THESE COYOTES!** – *Laura Koropatkin, President* ■

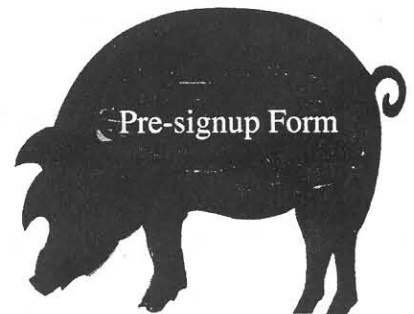
