

Looking out on the lake, it would appear that there is not much going on out there; too little ice for skating, too much for swimming. Looks can be deceiving however, and there is plenty going on down under the ice. The ice actually protects the cold blooded critters of the lake by providing some needed insulation by keeping the water temperature a few degrees above freezing. As long as the water doesn't freeze solid, down at the bottom the amphibians, insects and fish that winter in the mud will be fine. The cold water cools their bodies down to a point where they require very little in the way of food and oxygen. The cold lake water can hold a larger amount of oxygen than warm water. The oxygen content is supplemented by the photosynthesis which the microscopic plants perform in the frosty sunlight that filters down through the ice. Only a heavy layer of snow can prevent the sunlight from penetrating the depths and can cause death to the microscopic plants and the animals that rely on them for food.

The lake is a carefully balanced ecosystem. A hard freeze or heavy snow layers in only one winter can cause death to the whole ecosystem which can take years to correct.

Last summer we had an abundance of algae growth and weeds, especially in the more shallow coves around the lake. Like it or not, the abundance of these plants are the sign that the lake is a healthy body of water. Too many weeds and the sunlight can not penetrate into the zone where the algae (phytoplankton and zooplankton) eat the harmful microorganisms that can pollute the lake. Too much algae and the weeds which provide food and cover for the larger amphibian, insect and fish life will not receive the sunlight they need to maintain the balance.

I think I can safely say that there are few of us who enjoy getting our legs or lines caught up in the weeds. But if you do decide to remove the weeds from the swimming areas, it is best to remove them completely from the water. The excessive amount of detritus created by decaying vegetation can create as much of an imbalance in the lake as chemical pollutants. And remember; when you fertilize your lawns and gardens around the lake, you are fertilizing the lake water too. This can cause serious overgrowth issues too. The algae and weeds just love the nitrogen and phosphorous in the commercial fertilizers. Lets all do our part to keep our lake as healthy as it can be for now and for the future for folks to enjoy.

Traveling Salesmen

ASHFORD SENIORS!!!

Kay Warren will be holding a Yellow Dot Program at Chaffee Hall on April 22, 2006 from 10 a.m. to 1 p.m. What is the Yellow Dot Program? Ashford has been proclamated into the TRIAD in October, 2005. TRIAD is a trio of law enforcement (in our case Troop C), Ashford seniors and a business (which is People's Bank) combining together for senior safety. The Yellow Dot Program was done in December with about 30 Ashford seniors participating. We gave you a medical form to be filled out to put your medical information in and this is where your picture will also go. This will be kept in the glove compartment of your car, or whatever car you ride in the most. This is such that if you need medical attention out on the rode, the first medical personnel that reaches your vehicle will notice the TRIAD symbol on the rear window of your vehicle, will know to look in the glove compartment of your car for your medical information. With your picture on it, they know immediately who is who in the vehicle. We are the 39th town in the state of Connecticut to do this program. Attorney Richard Blumenthal hopes that within a few years all towns will have this program. TRIAD does other programs for the seniors as well-blinking lights, cell phone, and any senior safety programs that deem necessary to do. Even though you do not take any medications you should still fill out these forms. Any questions, call Kay at 487-3744. We will have someone at this session to take your picture.
