Dear Friends, Neighbors and Fellow Association Members,

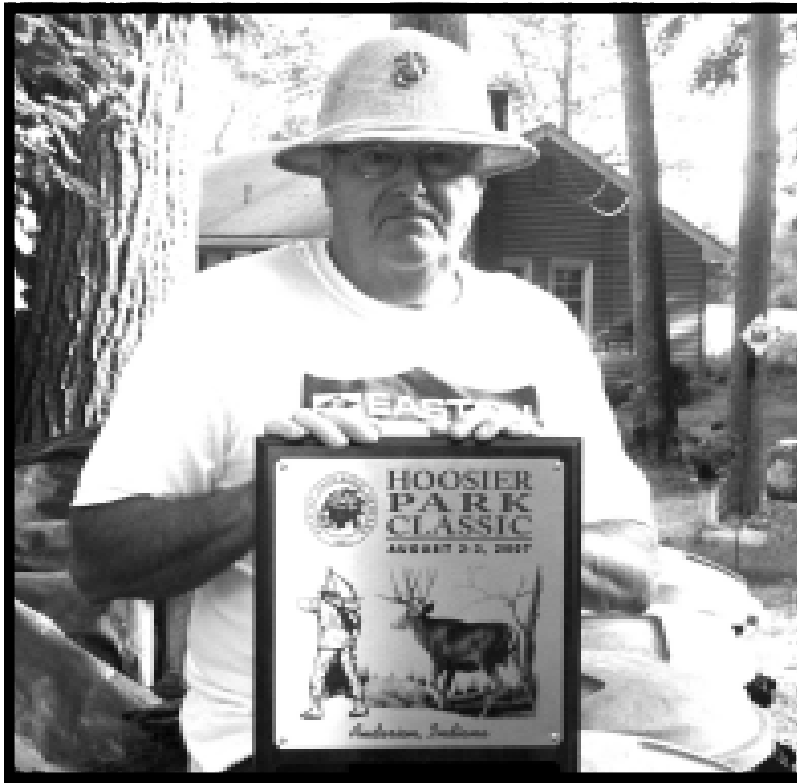

It was a shot that even William Tell would have been impressed by that won John Boutin of Maple Drive top honors at the International Bow Hunters Organizational Championship last Friday. Boutin, a long time resident of Lake Chaffee and veteran bow hunter, set out with cross bow in hand in the first week of August to compete against more than 17,500 bow hunters from around the world and returned home with first place in the amateur cross bow division. Boutin, modest about his victory, says, "It's really not that big of a deal because I wasn't shooting in the pro division. If I could have shot for the pros I would have come home with money." Boutin was not allowed to shoot in the pro championship due to qualification rules but vows to take gold next year when he competes. "I am going to get that gold buckle when I shoot next year... it's just like the ones the bull riders wear," says Boutin, "The money's not all that much but it's the buckle that everyone is shooting for." *So congrats John on a solid victory and LCIA is proud to have their very own Robin Hood living on our shores!*

State Boating Regulations


- Anyone 12 and over using an electric motor needs a boating license from the State of Connecticut. **NOTE: you boat needs to be registered.**
- Life jackets **MUST BE WORN** in all boats including canoes, row boats and paddle boats until May 31st. Thereafter, they must be in the boat/vessel with an appropriate life jacket size for each person plus one floatable device.
- THE STATE OF CONNECTICUT DEP will be conducting sporadic boat checks and inspections this summer.
- Anyone over the age of 16 must have a fishing license. Age 65 and over are free. Check with your town clerk.

The health inspector has made some suggestions on bringing our kitchen up to health codes by order of our new president, Chris German.

Volunteers have come forward to help with this project as the revenue from the kitchen has been depleted and we need to get the kitchen up and running as soon as possible. I am working with the health inspector; I am awaiting his permit so we can obtain the town permit. We will try to make this transition as easy as possible on everyone. ■

Dear Lake Chaffee Residents;

Mr. Dan Rackliffe, one of our residents, has called my attention to a non-aquatic invasive plant species, the Purple Loosestrife which has become a problem around the lake. This noxious weed is not native to our country. The plant is banned in Connecticut and must be eradicated if found on your land.

Purple Loosestrife is a tall plant resembling the Hollyhock. The pink to purple flowers grow close to the tall spiky stalk which may be branched. This plant is a perennial, prodigious seed producer and the millions of tiny seeds can be carried on the water, boats or wind. The roots of the Purple Loosestrife must be destroyed and the DEP recommends burning the plants if possible. If burning is not possible, the flower tops should be cut, bagged and disposed of at the transfer station. The remaining roots and plant clumps should be dug up and disposed of as described above.

Mr. Rackliffe enclosed print outs of pages he obtained from the <http://udsa.gov> website. I strongly recommend logging on to that web site if possible to view the pictures of the plant. Select the NCRS (National Resources Conservation Service) and click "Plant Database."

I would like to thank Mr. Rackliffe for providing this valuable information to us. It takes the whole community to do the best surveillance of our beautiful lake eco-system. Please feel free to call with observations or questions. If I don't have the answer, I will do my best to find the information for you.

When it comes to bingo Jack Pirzl is an icon. This is when he is the happiest.

Bingo was started in 1977 here at the Lake but Jack started calling the Lake Chaffee bingo in 1984—the year he became treasurer of the Lake Chaffee Improvement Association, Inc.

In 1948 Jack was presented a Good Citizen Award by the East Hartford VFW for being instrumental in helping to bring back the VFW to its full standards as of today. (see photo lower right) Jack was 16 years old. "This is where I learned the bingo trade," said Jack.

Jack graduated East Hartford High School in 1949 and that fall entered Northeastern University and graduated five years later in 1954 with a BS degree in Civil Engineering.

Upon graduation from college he entered the Army Artillery Service until December, 1956. After serving six years in the Army reserves he was honorably discharged in 1962.

In 1963 he married his longtime and devoted friend, Elizabeth Zelek. Liz died in 1995 after 32 years of marriage.

After the service he worked at Loomis & Sullivan, a land surveying company; then after there he went to work for the New York/New Haven Railroad in Hartford. He started to work for Pratt & Whitney in East Hartford when the railroad closed its Hartford office and went to New Haven. Jack retired as a test cell engineer in 1985.

Jack had two different pin numbers for calling bingo. He also volunteered his time at the St. Philip's bingo where he started calling in 1977 and he called almost every week until April, 2007 when St. Philip closed their bingo.

In 1997 Jack was honored by the members of Lake Chaffee when the inside of the hall was dedicated to Jack for the many years of exemplary service that he gave to Lake Chaffee. He would

not allow the outside of the hall to be named after him because he knew that the hall belonged to all the members of the Lake Chaffee Association.

Jack is a modest man. He never asks for much but he gives out much.

He was treasurer for Lake Chaffee for 23 years. In that time there never was anything wrong with his books and he was bonded every year of his service.

"Jack's books were right to the penny. His books were perfect," said Mary Michaud, the elected treasurer as of July 15, 2007. "He has helped me tremendously in my transition to treasurer," stated Mary.

You can stand outside Chaffee Hall every Saturday night and hear Jack calling bingo.

Jack never kept his honorarium—he donated it back to LCIA.

His hobbies are bowling, calling bingo, and playing cards.

"Just trying to see if you were awake," as Jack would say.

For 18 years Jack and I created and maintained mailing lists and property information for the Association. It wasn't an easy job, Jack did the research every week, and I maintained the database. We served together on the lake Board of Directors and Charter Commissions, worked together on lake water management processes, helped neighbors in times of need and shared a friendship. I can't say enough about Jack's kindness, compassion, thorough checking and recording of property data, his careful handling of association income, expenditures and assets in general. As Boards changed every year or two, Jack has always been the consistent Board member the town could send people to for answers; and people all over town know and deeply respect him. His contribution to Lake Chaffee and the Town of Ashford over all these years is unmatched. I am extremely proud to say that I worked with him for so long on such a regular basis.

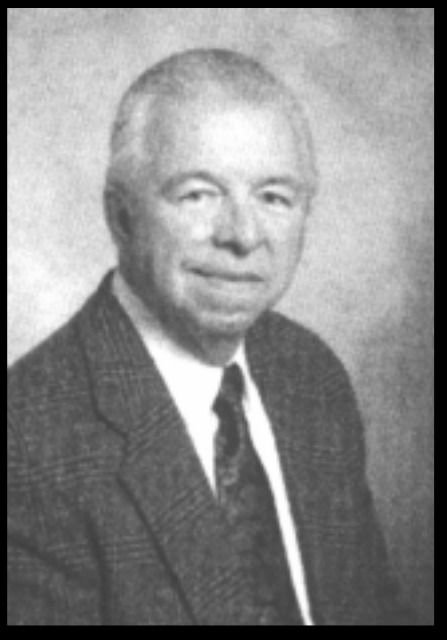

Your Personal Math Tutor is a supplement to textbooks on Algebra, Geometry, Trigonometry and Pre-Calculus, with aids for students preparing for the SAT exam, all in one book which can be passed on to siblings. There's no need to buy several books that each cover one topic.

Contrary to methods presented in textbooks he shows how to factor trinomials by inspection and investigation, rather than "trial by error." Who would want to be the pilot of an experimental airplane designed by trial and error?
